<u>University Funding & FAF Grants</u> – Liz Leckie

Student Services is receiving the best grant applications ever thanks to student advisors and Chairs and Directors who help their students write strong grants.

- FAF grants are due to the FAF Grants Committee representatives on Jan. 28, 2022
- FAF Grants Committee representatives (18 CFA undergraduate and graduate students) evaluate and award grants to College of Fine Arts Sponsored Student Organizations
- After Cycle I, \$42,693 in funding is available for awarding
- COVID-19 travel restrictions have been lifted. FAF Grants funding can now be used again
- In Cycle I, the School of Music received the most FAF Grants funding. Possible reasons are consistent faculty involvement and proactive student leaders

Career-line, Adjunct and Visiting (CAV) Faculty – Melonie Murray

The college will be proposing minor changes to the existing CAV policy, primarily adjusting the timeline so that the process will not overlap with RPT process. We are also looking to update the College Charter which has not been revised since its 2016 ratification. All proposed changes will be shared with College Council for discussion in Spring 2022.
